GENERAL INFORMATION & GUIDELINES

General Information

Arrival time on Monday: We do not serve lunch on Monday. The first activity is swim time for girls at 2:30.

Departure on Friday: Camp officially ends Friday morning after devotions and breakfast (we also ask that your cabins be cleaned and your assigned jobs for the week be completed before leaving).

Things to Remember

- Complete set of toiletries: towels, washcloths, toothbrush, soap, deodorant, flip flops for shower etc.
- Bedding: linens/sleeping bag (twin size bed), pillow, blankets etc.
- Camp Approved Clothing: sportswear, swimwear, nicer casual clothes for evening services and talent contest if participating (Everyone must arrive and depart in camp approved clothing- refer to dress code).
- Sleepwear: Boys should wear a minimum of shorts or pants. Girls should wear a minimum of shorts/pants and top or nightgown (sleepwear should only be worn in cabins).
- Jacket or Sweatshirt
- KJV Bible, Notebook and Pen
- Everyone must participate in all sports and activities (unless physically or medically not able).
- Spending Money: snack shop, gift shop, paintball (climbing wall is free of charge)
- Good Attitude!

Parents, thank you for sending your child to Triple "S" Christian Ranch! We promise to do everything in our power to see that your child is safe and well cared for while they're with us. Please make sure that your child understand and agrees to abide by all the rules while at Triple S. The breaking of camp rules can lead to your child being sent home to your expense. We love youth and want to help and teach them!

Dress Code

We ask for all dress to be modest and appropriate; not to include pop culture references, vulgarity etc. Triple S reserves the right for our staff to ask anybody, at anytime, to go change for any reason.

Girls: All dresses, skirts and culottes should be knee length and loose fitting. Tops should have a high enough neckline to where no cleavage is shown at any time. No midriff when arms are raised. No shorts, pants, capris and sleeveless dresses or tops. If an item is sheer the clothing underneath should meet dress code. No undergarments should be visible at any time. No two piece swimwear unless it meets in the middle (bikinis may be worn with a long dark shirt on top), and all private areas and midriff must be covered by swimwear. Camp approved clothing must be worn to and from the pool (no white shirts).

Boys: Must wear loose fitting pants and shirt at all times. No "skinny" or tight pants. Pants should be worn at the waist and not sagging...underwear or midriff should not be seen. No shorts except while swimming. You must wear pants and a shirt to and from the pool (no white shirts). We ask that boys not wear jewelry except for rings. If you wish to participate in the preacher boys session, please bring a collared shirt to wear and have hair cut off of the ears and collar.

Triple S has a no touch rule for members of the opposite sex that is to be maintained at all times. A male and female should never be alone or in an unlit area with each other at any time. Respect and purity should be shown to each other.

RULES

1. All climbers must have a current liability waiver on file before climbing. Participants under 18 must have this form signed by their parent or legal guardian.
2. Only those currently climbing are allowed in climbing areas.
3. Store all gear away from climbing areas. No glass bottles, food or drinks are allowed on the gym flooring. Closed toed shoes are required when climbing.
4. Participants must be at least 9 years of age to climb.
5. Foul language, horseplay, tumbling on landing mats, swinging on ropes, running, and unruly conduct are not allowed at Triple S Christian Ranch.
6. All climbers must use proper equipment.
7. All climbers must be trained or checked by staff prior to climbing. Breaking these rules is grounds for immediate removal.
8. No climbing or other related activity involving the rock climbing wall is allowed while under the influence of intoxicating substances, or substances which may cause physical or mental impairment.

We reserve the right to add to the above list as we see appropriate in an effort to provide a safe environment for our patrons. Refusal to abide by any rules can be cause for the loss of climbing privileges without a refund.

_____ I agree that I have read and fully understand the rules of the facility, and will abide by those rules, as well as others posted throughout the gym.

RELEASE AND ASSUMPTION OF RISK.

1. I acknowledge that climbing on an artificial climbing wall (referred to in this Agreement as "Climbing") can be dangerous. The inherent risks of Climbing are those that are normal or natural to that activity and cannot be eliminated with changing the primary nature of the activity. I acknowledge that there are inherent risks in the sport of indoor and/or outdoor rock climbing, including but not limited to those dangers associated with climbing, descending and belaying. Some of the hazards of climbing, including but not limited to, falling because of improperly placed, gear, loose or falling equipment or gear; getting dirt or other materials in the eyes; falling because of improperly tied knots or rope technique, or improperly buckled harnesses; acts of other participants; being hit by falling persons, equipment or debris; or falling onto another person, ledge or other protrusion; physical exertion; cuts, bruises, muscle and tendon strain, twisted or sprained ankles, rope burns, physical or emotional injury, paralysis, concussions, and even death, or other damage to myself, to property, or to third parties. I understand that there are more hazards than are enumerated here, and that there are also unknown and unforeseeable hazards. **I understand that no amount of care, caution, instruction or expertise can eliminate the inherent dangers associated with these and other activities.** I understand that climbing gear could become damaged or defective.

2. I confirm that I am physically and mentally capable of participating in all activities. I understand that if my mental or physical condition changes after the execution of this release such that I am not capable of participating in the activity or using the equipment, I am obligated to cease participation in the activities immediately.

3. I understand that wearing a helmet does not eliminate the dangers associated with Climbing but that in certain instances a helmet can reduce the risk of permanent injury or death. I understand that Triple S Christian Ranch recommends that I wear a helmet and that if I choose not to wear a helmet I do so against their advice.

4. I have read and agree to abide by the rules listed above on this waiver as well as other rules that may be posted throughout the facilities or climbing sites.

5. I acknowledge that any climbing instruction that I may receive from Triple S Christian Ranch is general in nature and may not apply to all climbing conditions. I understand that any instruction that I do receive does not prepare me to climb beyond my ability or without supervision.

6. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

MEDICAL AUTHORIZATION: I agree, on behalf of myself, or on behalf of any minor children for whom I have signed this Agreement, to authorize any medical treatment deemed necessary by Triple S Christian Ranch or third party emergency medical personnel, in the event of medical emergency, including injury of illness, while participating in the use of Triple S Christian Ranch equipment or facility. I agree on behalf of myself, or if a minor, I agree as parent or guardian to pay all costs of any medical services rendered on my behalf, or on behalf of the minor on whose behalf I am signing this Agreement.

ASSUMPTION OF RISK: I EXPRESSLY ASSUME ALL KNOWN AND UNKNOWN RISKS ASSOCIATED WITH MY PARTICIPATION IN OR USE OF ANY AND ALL FACILITIES OF TRIPLE S CHRISTIAN RANCH, INCLUDING RISKS OF INJURY, PARALYSIS OR DEATH, AND INCLUDING ANY RISKS ASSOCIATED WITH MY NOT WEARING A HELEMT, My participation in climbing and use of Triple S Christian Ranch facilities is purely voluntary and I choose to climb in spite of the risks.

RELEASE OF LIABILITY: I AGREE TO RELEASE AND FOREVER DISCHARGE TRIPLE S CHRISTIAN RANCH; and any of its members, officers, directors, employees, agents, representatives, sponsors, independent contractors, equipment manufacturers, and suppliers (collectively the "Released Parties"), from and against any and all damages, actions, claims, and liabilities, whether known or unknown, anticipated, suspected or unsuspected, resulting from ordinary negligence associated with my participation in any activity involving Triple S Christian Ranch or my use of or presence at the Triple S Christian Ranch facility with the exception of any willful and wanton, reckless or grossly negligent act or omission of the released party.

VENUE, JURISDICTION & WAIVER OF JURY TRIAL The laws of the State of Arkansas shall govern the rights and obligations of the parties to this Agreement and the interpretation, construction, and enforceability thereof. I agree that any lawsuit brought against the Released Parties shall be brought solely in the Circuit Court of Cleburne County, Arkansas. **I VOLUNTARILY WAIVE ANY RIGHT I MAY HAVE TO A TRIAL BY JURY** IN ANY ACTION INVOLVING ANY RELEASE PARTY.

INDEMNITY AGREEMENT

I agree, or on behalf of any minor children for whom I have signed this Agreement, to indemnify, defend or hold harmless the Released Parties from any loss, liability damages, expense or costs, including attorney's fees, incurred as a result of my participation in any activities or use of any facility.

I authorize Triple S Christian Ranch to use any photograph of me taken at any event sponsored by Triple S Christian Ranch to be used in promotional materials, brochures, and/or websites.

WAIVER AND RELEASE OF LIABILITY
